## **Highlights from Youth Engagement**

### **Climate Justice for Descent Communities**



13 August 2025 | In the wake of intensifying climate crises and widening inequalities, we organized a session exploring how climate change is deepening inequalities for Communities Discriminated on Work and Descent (CDWD). Youth leaders Sergen, Grijesh and Murilo highlighted the urgent need to confront patterns of environmental racism and systemic exclusion, and called for intersectional approaches that put affected communities at the centre of climate action.

### **Unpacking Migration: A Youth-Led Dialogue**

14 August 2025 | In partnership with Project PHEquiD, MYCP and One Future Collective, this youth-led dialogue, with the goal of gathering insights that would influence global agendas and policy focused on the conversations. The meeting intersection of caste and descent-based discrimination with displacement and migration. GFoD's Naveen Gautam emphasized the need for inclusive policies, data collection, and advocacy to address these issues. Arshiya discussed the importance of challenging dominant narratives around migration and displacement, advocating for empathy, solidarity, and action through storytelling and collective efforts.



**International Youth Day 2025: #HearUsNow** 



On 19th August, CDWD youth marked International Youth Day with a powerful call: we are not waiting to be spoken for: we speak for ourselves. The theme explored Local Youth Action for SDGs and Beyond, with a focus on SDG 6, 7, 9 and 11

Our powerful speakers included Isabella from the International Roma Youth Network, who highlighted how cultural centres and remembrance events empower Roma youth; Samir from Nepal, who led national policy change on menstrual dignity and now drives initiatives in 65 countries; and Dawda, who reminded us that marginalized youth are not only facing discrimination but leading change with dignity and inclusion.

As we look ahead to the 2nd World Social Summit, CDWD youth are breaking barriers across Europe, Asia and Africa, and demanding justice, equality and hope.

#### Advancing Roma Rights at Bulgaria's UPR Pre-Session



In partnership with Center AMALIPE, GFoD joined the week-long UPR Info Pre-Session on Bulgaria. In the Pre-session, on 29 August, our Roma rights expert, Magdalena Sarandeva highlighted the urgent need to address systemic discrimination against Roma and other CDWD. Alongside Paulo Lugon Arantes, GFoD's Geneva Representative, she also met with permanent missions in Geneva, advocating concrete recommendations for Bulgaria's upcoming UN review. These efforts ensure that the voices and struggles of marginalized communities are not overlooked as Bulgaria prepares for its UPR in November 2025.



Our very own Paul Divakar was the keynote speaker, stressing the urgency of addressing untouchability as a first step toward dismantling social hierarchies emphasizing that untouchability needs to be undone not only in South Asia, where casteism is entrenched, but also across other regions where communities such as the Roma, Haratine, Quilombola, and Burakumin face discrimination.

#### **Asia Dalit Rights Forum Calls for Universal Social Protection**

On 22 August, a delegation led by Bhakta Bishwakarma, General Secretary of the Asia Dalit Rights Forum, together with NGO Federation Nepal, met with EU representatives Mr. Thomas Miller, Deputy Head of Delegation, and Shiva Bhandari, Senior Program Manager. The team formally handed over a letter to the delegation and urged the EU to press for inclusion of Universal Social Protection Floors in the political declaration of the Second World Summit for Social Development.
