# History Made: UN Women and GFoD Launch First-Ever Policy Paper on CDWD Women and Girls



One of the most powerful highlights of HLPF 2025 was the joint release of a groundbreaking policy paper by UN Women and the Global Forum of CDWD (GFoD), addressing the specific concerns of women and girls from communities discriminated on work and descent (CDWD). The launch event, co-hosted by UN Women, GFoD, saw remarkable high-level participation. Member States such as Timor-Leste and the Czech Republic were in attendance, Gay Mcdougall, Vice-Chair, CERD moderated the session, Vice-Chair of UN Working Group on Discrimination against Women & Girls, laudia Flores also spoke. Video messages of solidarity came from the UN Special Rapporteurs on Racism and Minorities. The partnership between UN Women and GFoD was officially acknowledged in the printed edition of the brief-marking a historic step toward a more inclusive and representative vision of gender equality in global policy spaces. In a historic development, the Major Group for Children & Youth, in their speech at the High Level Opening of the HLPF 2025 delivered from the UN General Assembly called for the launch of a dedicated UN Forum on Communities Discriminated on Work and Descent.



## Youth participation at the HLPF 2025

TIP-GFoD amplified youth voices through dynamic participation from pre-Forum Youth Blast gatherings to leading discussions within the Forum itself, young advocates stepped forward as key contributors in shaping debate, sharing lived experiences and proposing concrete solutions for justice and inclusion.



### **Speakers from the Floor**

Naveen Gautam, as a Lead Discussant, addressed structural exclusion in the session on LDCs and

LLDCs. He urged governments to dismantle discriminatory systems and meaningfully include affected communities in decision-making processes for the SDGs.

Voluntary National Reviews (VNRs): Growing Recognition for Descent Communities in SDG Reviews





More than ever before, descent-based communities are being seen, heard, and acknowledged on the global stage, which is a powerful sign of change. At this year's Voluntary National Reviews (VNRs), we witnessed a landmark shift: the issue of discrimination based on work and descent / Descent communities was named and addressed in the Review more than ever. Three of our delegates, Gabriela Hrabanova (Czech Republic), Alima Taal (The Gambia), and from Nigeria, spoke on behalf of civil society, carrying the voices of Descent Communities and other marginalities into UN spaces. CSO statements from seven countries, i.e., Czech Republic, The Gambia, Nigeria, India, Malaysia, Bangladesh, and Japan recognized the struggles of descent communities. Moreover, Bangladesh officially acknowledged the challenges faced by Dalit communities during the review. These successes in the SDG reviews reflect the growing strength of our collective advocacy.

#### Leave No One Behind: Roma Voices in the 2025 VNRs

GFoD and TIP have been working alongside Roma civil society to ensure their voices are heard in the 2025 VNRs on the SDGs. From Bulgaria to Finland, Roma communities-long excluded from national development plans-are pushing back through independent shadow reports and civil society statements. The work highlights the urgent need for disaggregated data, accountability, and inclusive implementation of SDG 10 (Reduced Inequalities). ### **Building Alliances: Strengthening the Group of** Friends of CDWD at the UN



Our advocacy efforts during this year's HLPF marked another promising step forward in building global solidarity for Descent Communities. We met with the Permanent Representatives of seven countries, i.e., Tonga, Germany, Nepal, Czech Republic, New Zealand, Brazil, and Canada. These conversations have opened the door to potential collaborations and are a step forward in strengthening an evolving informal group of friends of CDWD at the UN. So far, we've engaged with 18 permanent missions, and the momentum is building: there is a strong possibility that three countries may come forward to jointly lead this initiative. With around 11 member states already informally part of this emerging group, we're getting closer to establishing a formal, cross-regional alliance committed to addressing descent-based discrimination at the highest levels.

### **Other Highlights**



TIP-GFoD delegates represented CDWD communities across multiple panels at HLPF 2025, speaking on issues ranging from inequality and decent work to climate justice and gender. Their presence and voice was a key contributing factor to visibility and inclusion of Descent Communities in global policy discussions.

#### Ministerial Declaration (para 73) calls for an end to discrimination in employment and occupation as key to tackling poverty and inequality

A meaningful step forward at HLPF 2025! While it doesn't explicitly name communities discriminated on work and descent, it's a sign that global conversations are beginning to reflect these realities.

At the 2025 ECOSOC Youth Forum (April 15–17), held under the theme "Youth at the Forefront: Leveraging Science and Social Inclusion for Sustainable Development," the Presidential Statement made a landmark acknowledgment of the realities faced by communities discriminated on the basis of descent. This recognition marks a significant step forward in amplifying the voices of youth from Dalit, Burakumin, Roma, and other descent-affected communities, and affirms the urgent need for inclusive development rooted in dignity and justice.


